## ACTIVITY REPORT OF THE MHRD CHAIR AT NALSAR UNIVERSITY OF LAW-2009-2010

#### **BACKGROUND:**

Prof.Vivekanadan nominated as the first IP Chair Professor was holding the chair till May 3<sup>rd</sup> of 2009. He went on lien to National Law of India, Bangalore as Professor of Law and Head of Distance Education Department and later on was appointed as the Dean of the Rajiv Gandhi School of Intellectual Property Law at IIT Kharagpur from July 20<sup>th</sup> of 2009 to April 27<sup>th</sup> of 2010. He rejoined NALSAR University of Law on April 28<sup>th</sup> of 2010 and assumed the MHRD Chair Professorship.

In his absence Dr.M.Sridhar Acharyalu, Professor of Law was appointed as the Chair Professor of MHRD Chair and the same was intimated to the Ministry.

National Seminar on WTO – TRIPS with special reference to Transactional IP Issues for Judicial & Enforcement Officers

- 2<sup>nd</sup> & 3<sup>rd</sup> May 2009

On 2nd and 3rd of May 2009, NALSAR University of Law along with the Ministry of HRD (Govt. of India) organised a two day National Seminar on WTO – TRIPS with Special Reference to Transactional IP Issues. The target group of seminar was judicial & enforcement officers along with students from the Intellectual Property and Technology Management in Agriculture course of NAARM Hyderabad. The seminar which was held at the R.N. Jhunjhunwala Conference Hall of the Justice City campus was inaugurated by Hon'ble Mr. Justice G. Raghuram, Judge, High Court of Andhra Pradesh.

The seminar had various sessions dealing with economic and legal perspectives of WTO-TRIPS, challenges to Indian innovations in the post TRIPS era, taxation issues in international IP transactions, emerging trends in IP investment, due diligence of IP, legal issues in IP services outsourcing, issues pertaining to transparency and accountability of IP transactions etc.
